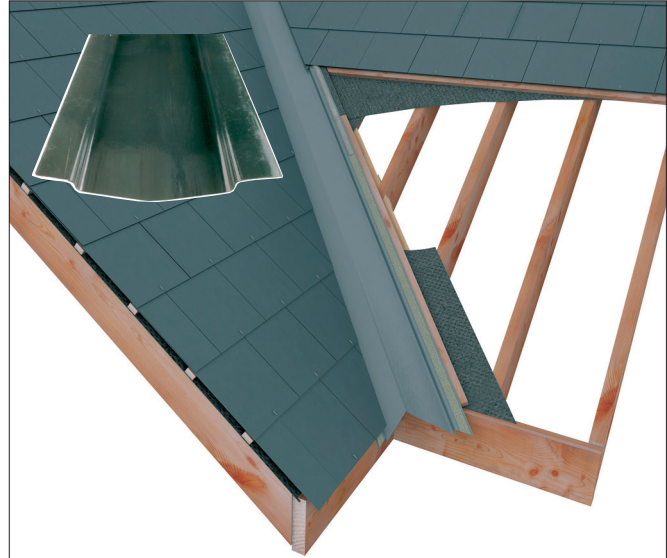
### HARCON GRP VALLEY TROUGH TYPE B

#### PRODUCT SCOPE AND SUMMARY OF CERTIFICATE

This Certificate relates to Harcon GRP Valley Trough Type B, for use to provide a weatherproof junction at features such as changes of direction and materials.

#### KEY FACTORS ASSESSED

**Weathertightness** — as part of a complete roof, the product will resist the passage of moisture into the interior of the building (see section 5).

**Properties in relation to fire** — tests indicate that the product when used as part of a complete roof will be unrestricted under the Building Regulations (see section 6).

**Strength** — the product has adequate strength to resist the loads associated with the installation of the roof (see section 7).

**Durability** — under normal service conditions the product will have a service life of at least 20 years (see section 9).

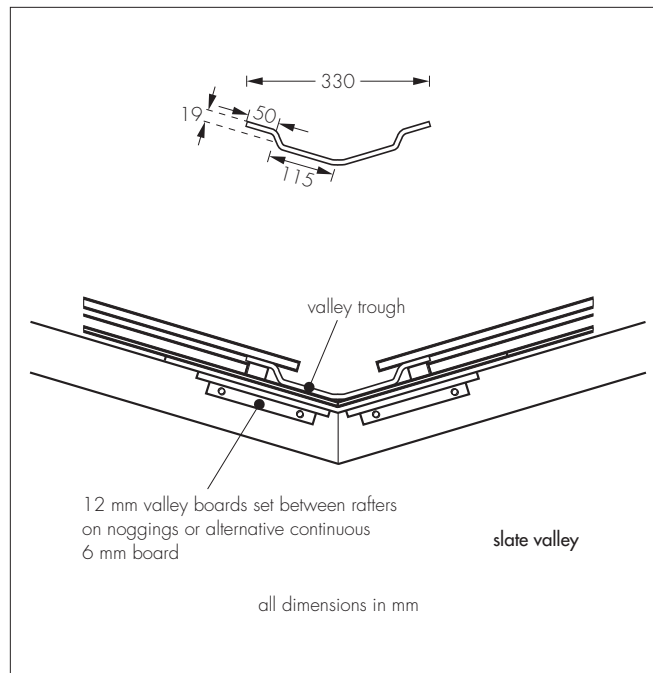
In the opinion of the BBA, Harcon GRP Valley Trough Type B, when installed and used in accordance with this Certificate, satisfies the requirements of the *Zurich Building Guarantee Technical Manual*, Section 4 *Superstructure*, Sub-section *Pitched roofs*.

# Technical Specification

## 1 Description

1.1 Harcon GRP Valley Trough Type B is manufactured from glassfibre/polyester laminate, in a continuous process to the profile illustrated (see Figure 1).

1.2 The troughs are manufactured to the nominal specification:

width (mm)	330
length (m)	1.8, 2.4, 3.0
standard colour <sup>(1)</sup>	grey/blue

(1) Other colours are available to order.

1.3 The valley trough is produced with an angle between the two sides of 17° and can be readily adapted by bending to accommodate roof pitches from 5° to 60°.

1.4 Quality control checks are performed on incoming materials, during production and on the final product. Checks on the final product include:

- visual inspection
- hardness
- weight
- dimensions.

## 2 Delivery and site handling

The valley troughs are delivered to site in packs of 10. Each item bears the BBA identification mark incorporating the number of this Certificate. Packs should be stored flat on a clean, level surface.

# Assessment and Technical Investigations

The following is a summary of the assessment and technical investigations carried out on Harcon GRP Valley Trough Type B.

## Design Considerations

### 3 Use

Harcon GRP Valley Trough Type B are satisfactory for use in slated pitched roofs constructed in accordance with the relevant Clauses of BS 5534 : 2003.

### 4 Practicability of installation

The product is designed to be installed by a roofing contractor, experienced with this type of product.

## 5 Weathertightness



Tests indicate that the product will adequately resist the passage of moisture to the interior of a building and so meet the requirements of the national Building Regulations:

**England and Wales** — Approved Document C, Requirement C2(b), Section 6

**Scotland** — Mandatory Standard 3.10, clauses 3.10.1 and 3.10.8

**Northern Ireland** — Regulation C4(b).

## 6 Properties in relation to fire



6.1 Samples of GRP, representative of that used in the manufacture of the product, when tested in accordance with BS 476-3 : 1958, achieved an EXT.S.AA rating.

6.2 Samples of GRP, representative of that used in the manufacture of the product, when tested in accordance with BS 476-7 : 1987, achieved a Class 3 surface spread of flame.

## 7 Strength

The product will resist the normal impacts associated during installation and use.

## 8 Maintenance



Minimum maintenance is necessary and the smooth surface finish will inhibit the build up of foreign matter.

## 9 Durability



Available test data and knowledge of the material suggest that the product, when installed in accordance with this Certificate, should have a life of at least 20 years.

# Installation

## 10 General

10.1 Installation of Harcon GRP Slate Valley Trough Type B must be in accordance with the Certificate holder's instructions and the relevant recommendations of BS 5534 : 2003 and BS 8000-6 : 1990.

10.2 The sections must be cut to size with a fine-toothed saw and can accept holes being drilled using a sharp drill bit.

## 11 Procedure

11.1 It is recommended that valley boards, 12 mm boards supported on noggings between rafters or, alternatively, 6 mm boards laid over rafters, are used. Valley troughs can be installed without the use of valley boards provided the trough is pushed down tightly against the rafters and is drilled and nailed correctly. However, foot traffic must be avoided. Alternatively, a heavier 'X' grade valley trough weighing 2.4 kg·m<sup>-2</sup> is also available reducing the need for valley boards.

11.2 The valley must be lined longitudinally with reinforced underlay one metre wide. A length of the trough should be pressed to a tight fit into the valley and the line of the outer edges marked. The pitch angle of the valley trough, originally 17°, will adapt to suit pitches from 5° to 60°.

11.3 Counter battens of similar size to the roofing battens must be fixed along the marked line to support the edges of the trough, using nails of a quality acceptable in good roofing practice.

11.4 Commencing at the foot of the valley, troughs must be nailed at 400 mm spacings to the counter battens through drilled holes.

11.5 Consecutive lengths of valley trough must be laid allowing a 150 mm overlap at the joints, finally trimming the head and foot of the valley.

## 12 Repair

Damaged areas can be repaired by following the Certificate holder's instructions prior to completing the roof covering.

## 13 Finishing

The tiling must be carried out in accordance with the relevant Clauses of BS 5534 : 2003, and BS 8000-6 : 1990.

# Technical Investigations

## 14 Tests

Samples of the slate valley trough sections and representative samples of the material were supplied by the Certificate holder for testing. Tests were carried out in accordance with MOAT No 9 : 1973 to determine:

- density
- resin/glass ratio
- dimensions
- hardness
- tensile strength/elongation
- cross-breaking strength
- effect of elevated temperatures
- effect of water soak
- impact resistance.

## 15 Investigations

15.1 The results of fire tests on samples of GRP used in the manufacture of the product, carried out in accordance with BS 476-3 : 1958 and BS 476-7 : 1987 by an independent test authority, were assessed.

15.2 The manufacturing process was examined, including the methods adopted for quality control, and details were obtained of the quality and composition of the materials used.

16.3 This Certificate will remain valid for an unlimited period provided that the product/system and the manufacture and/or fabrication including all related and relevant processes thereof:

- are maintained at or above the levels which have been assessed and found to be satisfactory by the BBA
- continue to be checked as and when deemed appropriate by the BBA under arrangements that it will determine
- are reviewed by the BBA as and when it considers appropriate.
