BBA Product Assessment and Certification

UKCA is a new UK product marking that is used for goods being placed on the market in Great Britain (England, Wales and Scotland). It covers most goods which previously required CE Marking to harmonised standards.

The UKCA Marking alone cannot be used for goods placed on the Northern Ireland market, which require the CE marking or UKNI Marking.

The BBA can assist manufacturers in the UKCA (UK Conformity Assessed) Marking process for products with:

- AVCP System 1 and 1+, by providing an assessment of Constancy of Performance.
- AVCP System 2+, by providing an assessment of Certificate of Conformity of the Factory Production Control.
- AVCP System 3, by providing UK Approved Body test reports on the basis of your EU.

UK Technical Assessment

The BBA can assist manufacturers with UKCA or UKNI Marking for products that do not have a Designated Standard by carrying out a UK Technical Assessment (UKTA). This is the equivalent of the ETA used for CE Marking on the EU market.
