





Many of the BBA products you hold will be unaffected by the end of the transition period, as they are unrelated to the CPR regime



## UKCA marking - Which route do I follow?

Moving to the UK-CPR and UKCA Marking regime will take different forms depending on factors such as:

- The nation in which your company is based
- The markets you sell into
- Whether your product is covered by a harmonised Standard or not
- Your AVCP level (where applicable)
- Whether your ETA was issued by a UK or EU TAB

Whether your third-party conformity tasks are carried out by a UK Approved or EU Notified Body

Whether it is an existing product or a new product (i.e. whether it was CE marked at the end of 2020)



## Marking by market

### The UKNI marking must accompany another conformity marking; it never appears on a product alone

Type of good (see list of product areas below)	Accepted marking or combination of marking*	
Placing goods on the market in Northern Ireland	Manufactured goods being placed on the market in NI using an EU conformity assessment body	CE
	Manufactured goods being placed on the market in NI using a UK- based body	CE and UKNI
Discing goods on the market in Creat Britain	Manufactured goods being placed on the GB market until the end of 2021	UKCA or CE
Placing goods on the market in Great Britain	Manufactured goods placed on the GB market from 1 Jan 2022	UKCA
Placing qualifying Northern Ireland goods on the market in Great Britain (unfettered access)	Qualifying Northern Ireland goods being placed on the GB market under unfettered access	CE or CE and UKNI
Placing goods on the EU market	Manufactured goods being placed on the EU market	CE



### **Multiple Marking and Declarations of Performance**

- Potentially a product could require all three marks, if it is to be sold in all three of the EU (including ROI), GB and NI markets. The marks should be positioned separately to avoid any confusion
- New legislation will allow products meeting Northern Ireland product bearing the CE marking or CE with UK(NI) to be placed on the entire UK market from 1st January 2022
- UK(NI) marking will not be accepted by the EU
- Declarations of performance continue to be required. If you wish to affix both the UKCA mark and CE mark to your product, you will need separate valid Declarations that meet both the GB and EU CPR regimes' requirements
- For the UK market, these declarations are to be known as Declarations of Conformity, not Declarations of Performance and must reference the UK Conformity Assessment Body, where appropriate









### **Notified Bodies**

### We currently have CE Marking through an EU NB or TAB – can the BBA carry out the conformity assessment tasks to support UKCA marking?

• Yes. The BBA is a UK Technical Assessment Body (equivalent to the current TAB) to issue UKTAs for a wide range of construction products, and a UK Approved Body (equivalent to the old NB) for product



### **Notified Body co-operation**

### Will EU and UK notified bodies cooperate?

- Yes. The UK Government says:
- Page 56 item 3(f) of the Agreement will
- "Allow conformity assessment bodies to use subcontractors to perform testing or inspections, including subcontractors located in the other Party's territory"
- For 2+ factory production control
  - UKCA only existing Certification remains acceptable and can be converted for a nominal fee
  - CE only the BBA has formed partnerships with EU based Notified Bodies and can put you in contact
  - UKCA and CE marking using the above partnership arrangements a single audit can usually be used as the basis for separate Certification supporting CE and UKCA marking

### "EU Notified Bodies are required to share information with UK Approved Bodies when requested by a certificate holder, and UK Approved Bodies should do the same with EU Notified Bodies. This will help facilitate the issuing of new certificates of conformity, where needed, without the need to repeat the entire certification process."





















## **Notified Body Testing**

- The EU has not accepted UK based Notified Bodies and retesting has been required
- The BBA has lobbied for mutual recognition, but this seems unlikely
- The BBA would like to accept test reports from EU Notified Bodies towards UKTAs, subject to Government approval
- MHCLG have drafted, but not yet published, transitional proposals (possibly including)
  - Approved Bodies may assess existing EU Notified Body reports and these assessments may be accepted in place of a UK test report
  - Reports pre Brexit and <5 years old</li>
  - UKAS accreditation required
  - Transitional period only (18 months?), thereafter, full duplication of testing required
  - Transitional period may be extended to align with the Building Safety Bill
  - All provisional and to be confirmed



### **Standards**

### **Does the BBA cover the Standard that I need?**

- The BBA has a wide scope of Standards on the existing UKMCAB schedule: 0113Product Certification (ukas.com)
- We are working with UKAS and MHCLG to simplify the process of adding new Standards We are seeking flexible scope for all Certification activities
- Negotiations continuing but time restrictions exist

### If a harmonised standard changes, will the UK automatically follow the changes in the UK **Designated Standards?**

likely that EU and UK standards will diverge at some point in the future

Not necessarily. Although the convenience of keeping the standards in parallel is widely recognised, it is



### UKTAs

### Is there an equivalent to EOTA under the new system?

- At the moment, no, but this is under discussion
- The BBA has engaged with MHCLG and EOTA on this topic
- We are waiting for details on how the scheme will operate
- The BBA will be in a position to issue UKTAs once the processes are defined
- The BBA will remain an Observer to EOTA, to maintain involvement
- The BBA has a unilateral agreement with EOTA and so can issue UKTAs for existing EADs and ETAGs
- The process has not been fully defined by MHCLG and so is subject to approval
