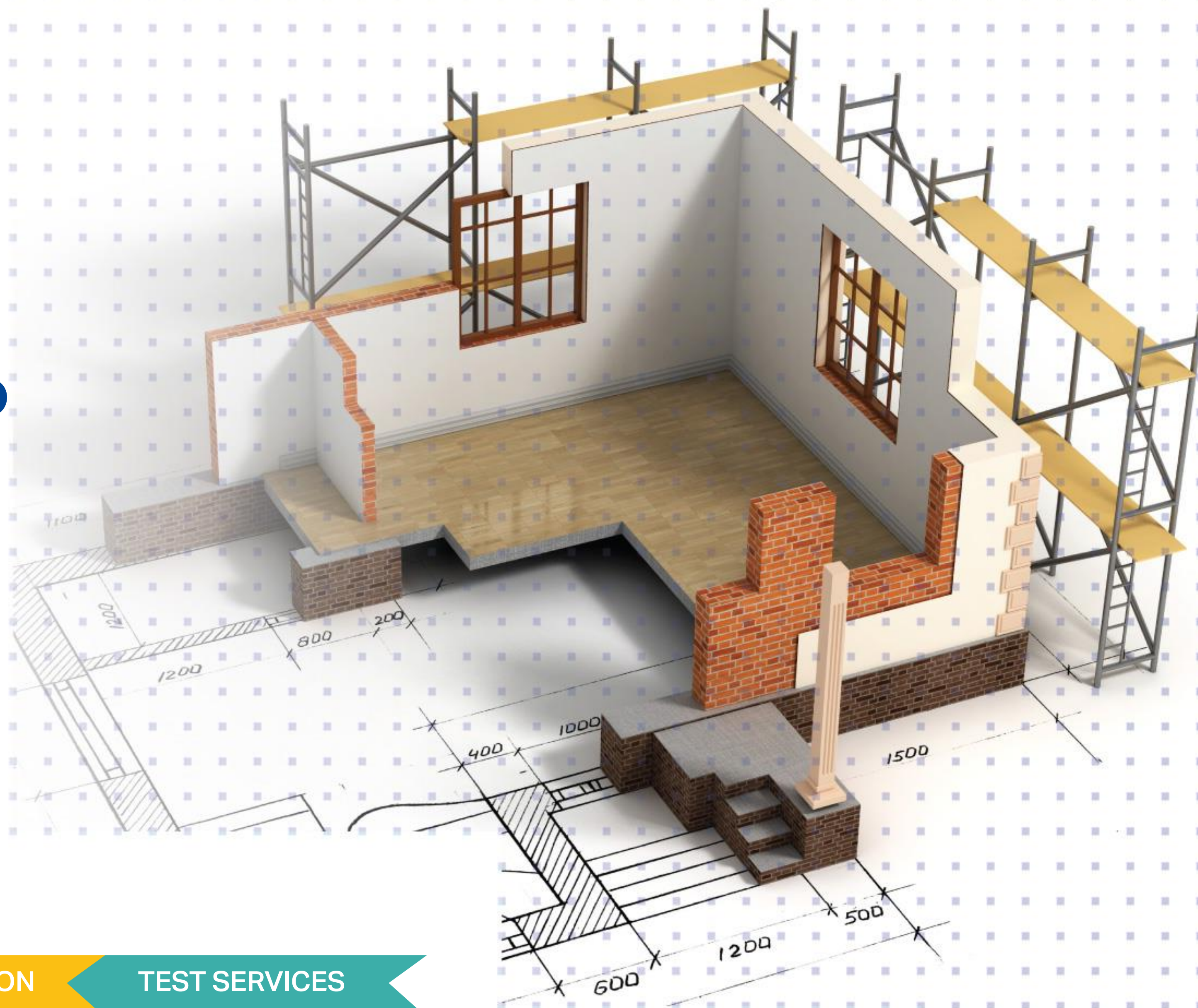

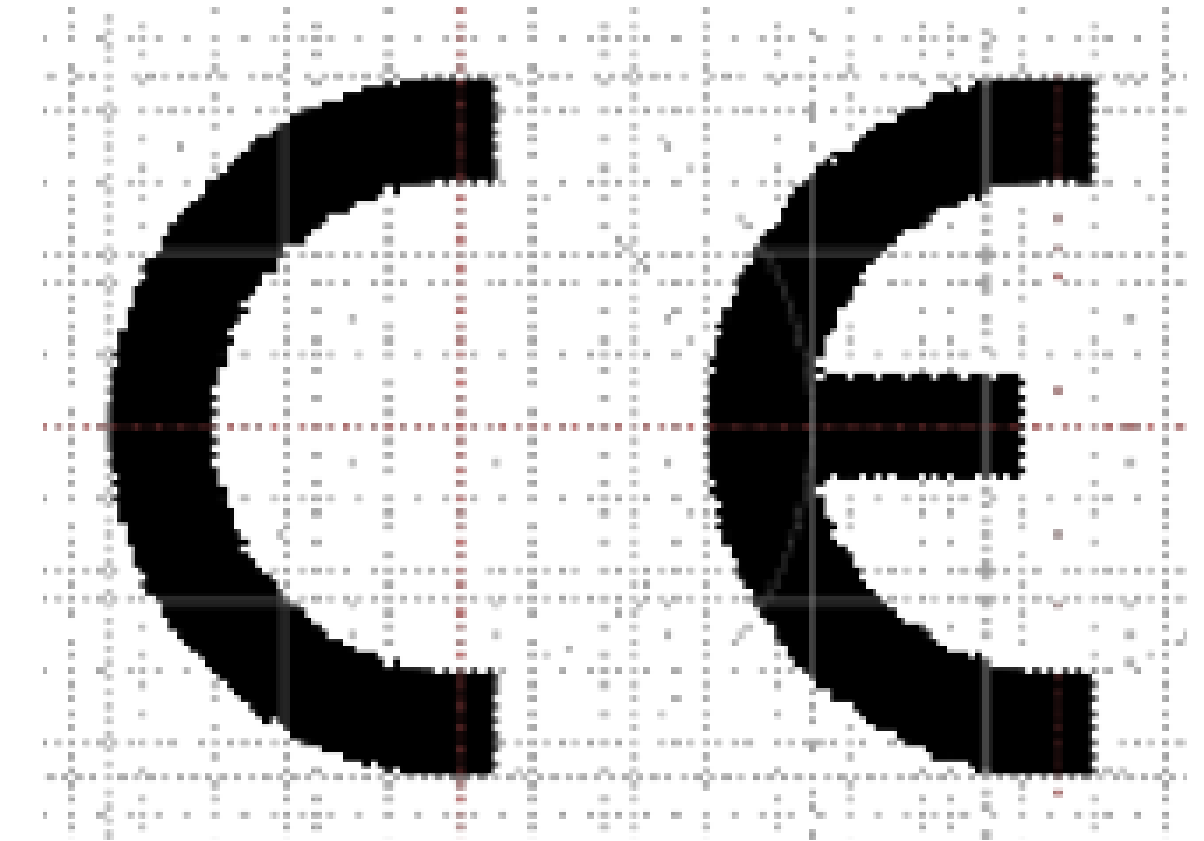

Background to CE Marking

- EU Construction Products Regulation 2013
- Product Passport to the European market
- Consistency of declared performance
- Two routes
- Mandatory – via harmonised standards (hENs)
- Voluntary – via European Technical Assessment Guidelines (ETAGs) / European Assessment Documents (EADs) and the issue of European Technical Assessments (ETAs)



What is UKCA marking?

- **United Kingdom Conformity Assessed (UKCA)** Marking will replace CE Marking for any applicable products that are or will be placed in the GB market.
- Mandatory for NEW applicable (designated/harmonised) products placed on the GB market from **1st January 2021**.
Mandatory for ALL applicable products placed on the GB market from **1st January 2022**.
Existing CE Marking will be recognised in the GB until **1st January 2022**.
- Note: Conformity tasks must be carried out by a UK Approved Body.

What is a UKTA?

- UKTA stands for United Kingdom Technical Assessment
- These are a mirror of ETAs for the UK market
- These can be issued by UK TABs, provided they are competent in the defined product area
- BBA have the widest product range of the 9 UK TABs
- This is a voluntary process for the UK including NI
- Applicable from 1 January 2021
- ETAs will no longer be recognised in GB from 1 January 2022
- Existing ETAS issued by the BBA were transferred to EU TABs before 31 December 2020

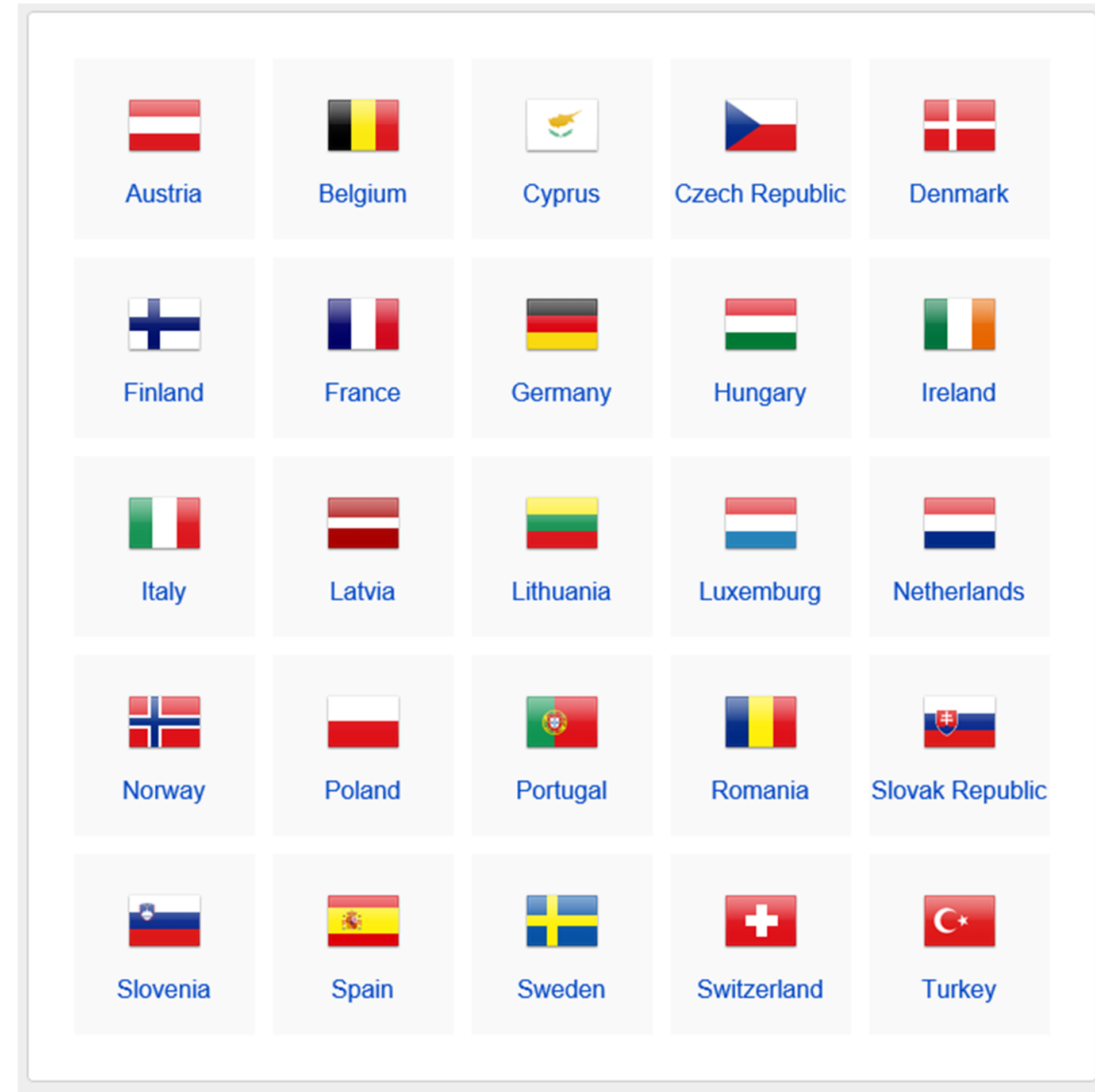
European Organisation for Technical Assessments (EOTA)

- Co-financed by the EC
- Develops and adopts EADs
- Ensures best practises are shared between members and that adopted EADs and references to ETAs are publicly available.
- Works with the EC, EU Member and EFTA States, the European Standardisation Organisations, and other stakeholders in research and construction such as European Contractors, Manufacturing, Technical and European Research Associations.
- The European Technical Assessment (ETA) provides an independent Europe-wide procedure for assessing the essential performance characteristics of a construction product.
- The ETA offers manufacturers a voluntary route to CE marking, where the product is not or not fully covered by a harmonised standard (hEN) under the CPR.



EOTA and EU Technical Assessment Bodies (TABs)

- EOTA is set up by the Regulation (EU) No 305/2011
- Comprises all Technical Assessment Bodies (TABs) designated by Member States of the EU and the European Economic Area.
- A country subject to a mutual recognition agreement (MRA) with the European Union is also considered for membership.
- 25 member countries with 47 TABs
- Over 6000 Current ETAs
- Website www.eota.eu



UKCA marking - Which route do I follow?

Moving to the UK-CPR and UKCA Marking regime will take different forms depending on factors such as:

- The nation in which your company is based
- The markets you sell into
- Whether your product is covered by a harmonised Standard or not
- Your AVCP level (where applicable)
- Whether your third-party conformity tasks are carried out by a UK Approved or EU Notified Body
- Whether your ETA was issued by a UK or EU TAB
- Whether it is an existing product or a new product (i.e. whether it was CE marked at the end of 2020)

Why Convert to UKTA?

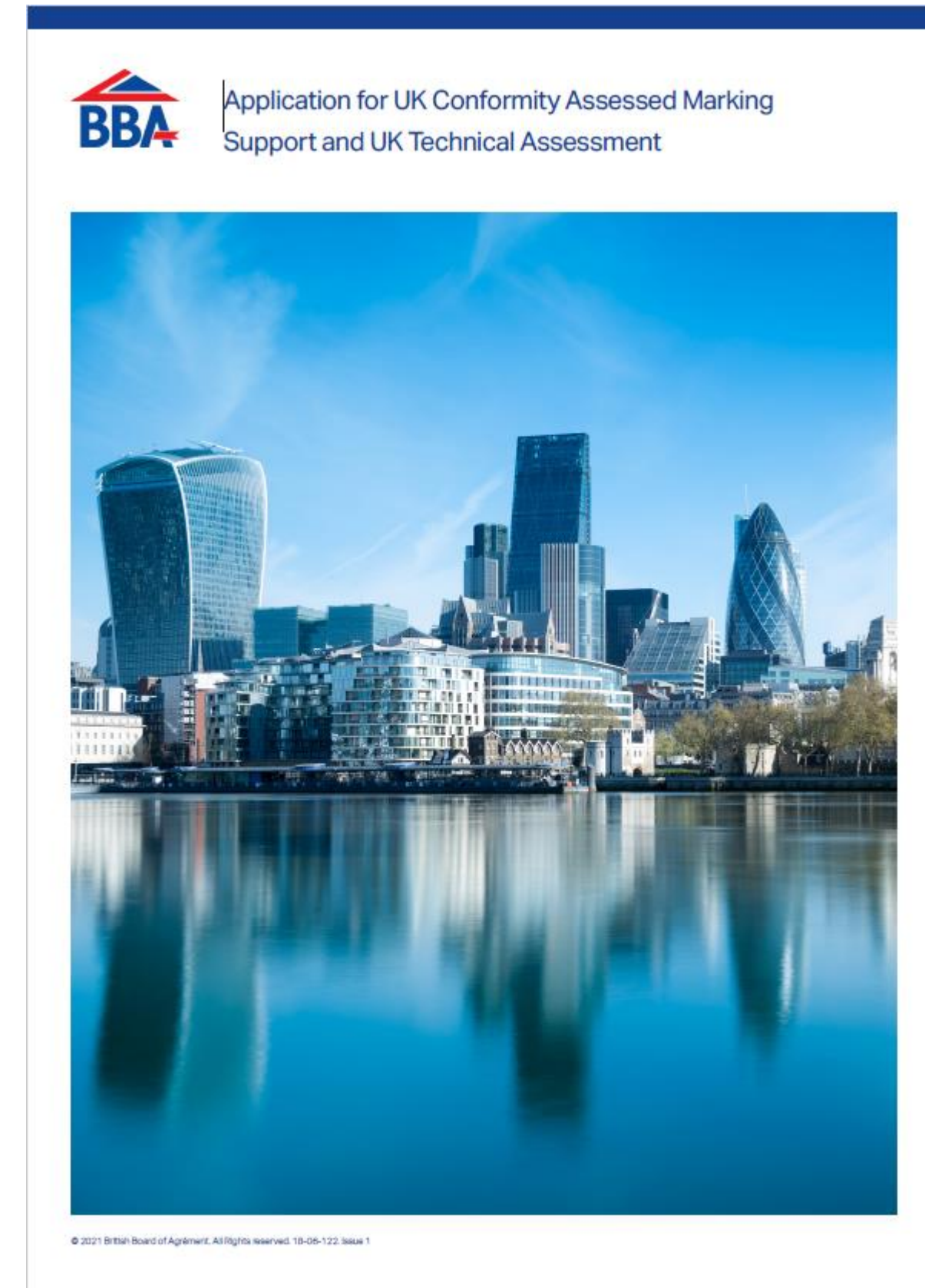
- Recognised by UK specifiers
- Access to the UK Market
- Simple and quick conversion process
- Uses your existing ETA for ease of conversion
- Working with your existing EU Technical Assessment Body
- Future specification may demand UKTA
- ETAs will no longer be recognised in the UK as of 2022
- UKTA's can be a quick and simple route towards a UKCA Marking
- Allows the use of UKCA Marking on products not covered by Designated Standards (formerly hENs)
- Acts as a stepping stone towards gaining a national technical approval – a fully-fledged BBA Agrément Certificate

The 4 Easy Steps to UKTA Conversion

1. Application

2. Programme of Work

We will prepare all the appropriate contract documents and issue a programme of work based on:

- a) Evaluation Report from issuing EU TAB or EOTA
- b) Associated Test Reports (if required)
- c) Manufacturer's Technical File / factory production report

3. Data Assessment

The BBA...

- Works with your existing EU Technical Assessment Body and evaluates the data.
- Prepares the UKTA and circulates for comment if required.
- The UKTA is a mirror of the ETA Certificate, initially these may refer to the EAD/ETAGs and if necessary will be reissued once the nomenclature has been agreed with MHCLG.

4. UKTA Issued

- The UKTA is issued by the BBA to support the Applicant's UKCA Marking (2 months from receipt of data).
- Surveillance to the place of manufacture will be conducted by the EU TAB's nominated Notified Body depending on the AVCP level, 1, 1+ or 2+ with no NB requirements for level 3. The BBA receives the reports from the NB

UKTAs

Is there an equivalent to EOTA under the new system?

- At the moment, no, but this is under discussion
- The BBA has engaged with MHCLG and EOTA on this topic
- We are waiting for details on how the scheme will operate
- The BBA will be in a position to issue UKTAs once the processes are defined
- The BBA will remain an Observer to EOTA, to maintain involvement
- The BBA has a unilateral agreement with EOTA and so can issue UKTAs for existing EADs and ETAGs
- The process has not been fully defined by MHCLG and so is subject to approval

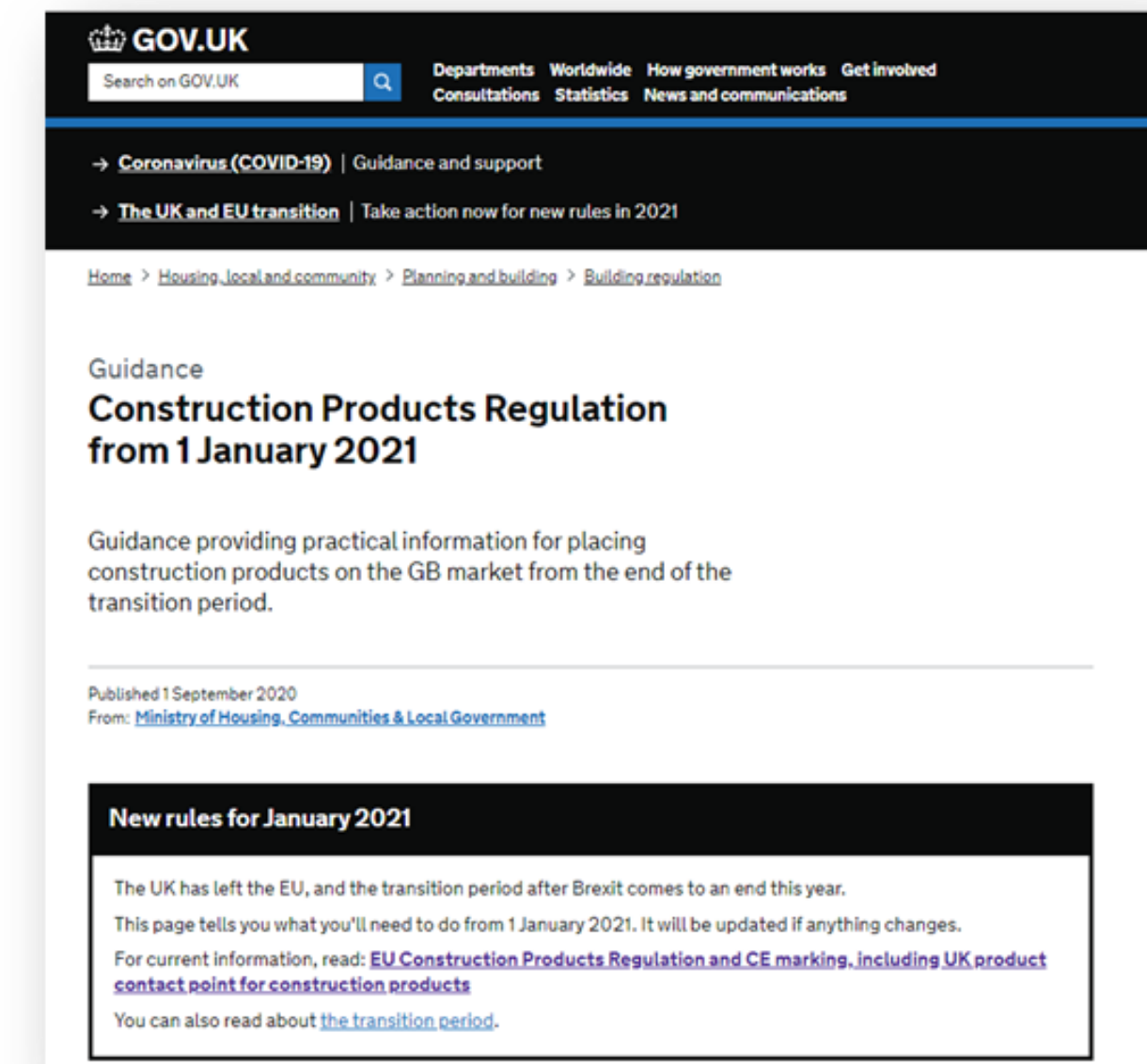
